1. 6. The Lessee shall take all necessary care to keep the premises neat and clear in sanitary condition matching the environment and cleanliness of such building.
7. The Lessee or its nominees shall not be entitled to sell and/or store any combustible or hazardous materials including materials like Petroleum, Kerosene, gas, spirits etc. in the space held by the Lessee except to the extent required by the Lessee for its own use and at its own risk.
